By-law 2374, as amended from time to time shall be further amended as follows:

It is ordained and enacted by By-law No. 2374-2: as follows:

ARTICLE 1:

SECTION 1.16 of by-law 2374 is hereby amended to replace the words "*Tobacco Act R.S.Q. Chapter T-0.01*" with the words "*Tobacco Control Act, R.S.Q, chapter L-6.2*".

ARTICLE 2:

By-law 2374 is hereby amended by adding the following definition after article 1.17:

1.18 Cannabis:
All cannabis products, its concoctions or derivatives, in whichever form.

ARTICLE 3:

The second paragraph of SECTION 2 of by-law 2374 is hereby amended to add the words "and Cannabis" immediately after the words, "Electronic Cigarettes".

ARTICLE 4:

The eighth bullet point of paragraph 3 of SECTION 3 of by-law 2374 is hereby amended to remove the words "within 20 meters of any".

ARTICLE 5:

The ninth bullet point of paragraph 3 of SECTION 3 of by-law 2374 is hereby amended to add a comma after the word "parks" and to add a comma and the words "greenspaces, municipal dog runs and Community Gardens" after the word "Event".

ARTICLE 6:

ANNEX A of By-law 2374 to Regulate Smoking in the City of Côte Saint-Luc will be replaced by various signage delineated within ANNEX A of By-law 2374-2 which will form an integral part of the present by-law.

ARTICLE 7:

This by-law comes in to force according to law.
