# ADOPTION OF SUBCATEGORIES FOR NON-RESIDENTIAL IMMOVABLES FOR THE 2020-2021-2022 ASSESSMENT ROLL

WHEREAS section 244.64.1 of the *Act Respecting Municipal Taxation* ("Act") allows any local municipality to divide the composition of the non-residential category, as provided for in section 244.33, into a maximum of four subcategories of immovables, including a reference subcategory;

WHEREAS the City of Montreal Property Assessment Services intends to deposit the 2020-2021-2022 assessment roll on September 11, 2019;

WHEREAS section 244.64.2 of the Act states that "any criterion for determining the subcategories, other than the reference subcategory, must be based on a characteristic of the non-residential immovables entered on the assessment roll";

WHEREAS the Côte Saint-Luc City wishes to establish four subcategories based on the utilisation code of non-residential immovables entered on the 2020-2021-2022 assessment roll;

THAT the City of Côte Saint-Luc send a copy of this resolution to the assessor responsible for preparing the assessment roll;
