Instructions

- The city reserves the right to verify all applications, including visiting the dwelling to ensure conformity to the by-law and to deny, void or cancel any applications. All city decisions are final.
- The application must be accompanied by a photocopy of:
 - driver's license for everyone residing at the dwelling;
 - vehicle registration for all vehicles registered at the dwelling;
 - proof of residency;
 - a signed attestation when so required (category B)
- The applicant must notify the city of any changes to the information provided above, including change of vehicles or license plate. Missing or inaccurate information may result in the issuance of a notice of infraction.
- A one-time fee of \$35 will be charged for slope measurement.
- Marked commercial vehicles, trailers, campers, busses and large trucks are not permitted to be parked overnight on any street and are therefore not eligible for a permit.
- Permits only allow parking between 3 am and 6 am. All other parking restrictions must be respected.
