QUESTION PERIOD

The question period started at 8:24 p.m. and finished at 8:48 p.m. Three (3) people asked to speak and they were heard.

1) Tamar Hertz

The resident inquired about women being excluded from the Côte Saint-Luc Men's Club and requested the City intervene regarding this matter as they subsidize the club.

Mayor Brownstein responded that it is not discrimination when a club is created for a specific group of people. Mayor Brownstein also mentioned that the Men's Club provides many services to Côte Saint-Luc residents such as: events, entertainment, workshops and other educational clinics. He then emphasized that the numerous services provided to residents by the Men's Club alleviates the City from providing them.

2) Irving Itman

The resident mentioned that he attended the public consultation on the Royalmount project. He also mentioned that the interview given by Mayor Brownstein to the CBC on the topic of crossing Décarie was forceful. He then expressed his dissatisfaction with the lack of foresight to alleviate traffic on Décarie given all of the development occurring in the surrounding area. Mayor Brownstein responded that while this is an agglomeration competence, Côte Saint-Luc has given many helpful solutions; in particular, asking the agglomeration to emphasize public transportation around the area in order to *move people* (not only cars).

3) Filomena Golfi

The resident inquired about the traffic (deviation) signs on Glencrest Avenue and mentioned that the new traffic configuration puts the security of children attending Merton School at risk since traffic has now been deviated around the school. Councillor Berku responded that residents on Glencrest Avenue have expressed their concern regarding traffic safety in their area and that is why the City held a public consultation on the subject and studied the matter thoroughly. Councillor Berku then mentioned that since the implementation of the new traffic configuration there has been no complaints or accidents that she is aware of and there is less traffic on Baily Road. Councilor Berku also mentioned that the Engineering Department is still reviewing the matter and therefore, the whole issue will be reviewed in due course.

Mayor Brownstein then responded that the resident is most welcome to meet with representatives of the Engineering Department directly to discuss the matter further if she so wishes. The resident then asked if there was a timeline for the conclusions to be reached by the Engineering Department to which Councillor Berku answered that there is no specific timeline as of right now.
