OPENING STATEMENT BY THE MAYOR CONCERNING THE COVID-19 VIRUS

Prior to the holding of tonight's council meeting, Mayor Brownstein asked that a moment of silence be observed for the people who have passed away due to the COVID-19 virus.

QUESTION PERIOD

The question period started at 8:07 p.m. and finished at 8:24 p.m. Seven (7) residents submitted questions prior to the holding of tonight's meeting and they were answered during the live feed.

1) Tania Alfonsi

The resident, who is the owner of the duplex located at 5767-5769 Eldridge, inquired about the enforcement of zoning and construction by-laws for the neighboring duplex located at 5771-5773 Eldridge; to which Mayor Brownstein responded that when the City was made aware of renovation work for this particular address, no construction permit was issued and that statements of offenses will be issued due to the construction work without a permit.

2) Louise Legault

The questioner inquired about the diversion of the Toe Black collector in Meadowbrook, more specifically, the number of cross-connections that have been identified in the City of Côte Saint-Luc and when these cross-connections will be corrected; to which Mayor Brownstein responded that the Engineering Department is currently analyzing the situation and will be providing Council with an update on the matter. He further mentioned that the number of cross-connections in the City is low and that the City is willing to collaborate with residents to remedy the situation.

3) Wibke Sheid

The resident inquired about the establishment of meadows in the City, more specifically, if the City is planning on letting the grass grow in certain vacant lots; to which Mayor Brownstein responded that on very hot days, the Public Works Department keeps the grass at a reasonable length and that By-law 2470 concerning nuisances applies on its entire territory (the limit being 15 cm in length). Mayor Brownstein further explained the reason behind the 15 cm rule.

4) Fernanda Cano

The resident inquired about four (4) different matters, namely:

- People blocking the entrance to her driveway with their vehicles; to which Mayor Brownstein responded that calling Public Security is the right action to take and that the City posts communications to remind the population that blocking driveways is illegal;
- The enforcement of City by-laws, more specifically, concerning the diameter of new replacement trees; to which Mayor Brownstein responded that the 5 cm diameter rule was established to allow trees to grow safely and to protect the environment;
- The delay to reimburse residents that have planted a new replacement tree; to which Mayor Brownstein responded that given the current circumstances related to COVID-19, the reimbursements are taking longer, but the City will try to be more efficient; and
- The adoption of a by-law prohibiting smoking on the entire territory of the City, similar to the one in Hampstead, as it is a concern for children in the City; to which Mayor Brownstein responded that the City's smoking by-law has always been more strict that the Provincial laws governing smoking and that smoking is prohibited in areas where children are most often present, such as parks.

5) Rocco Amico

The resident inquired about the number of homes that currently have a municipal tax exemption on Eldridge and Melling; to which Mayor Brownstein responded that there are three (3) fully exempt homes and one (1) partially exempt home on Eldridge, and none on Melling.

6) Toby Shulman

The resident inquired about the wearing of face-coverings in common areas of condominium complexes and apartment buildings, more specifically, if the City will be taking further measures to make it mandatory in these areas; to which Mayor Brownstein responded that he is in agreement with the resident's proposal, but that the enforcement of such measures would be an issue; as opposed to commercial establishments where the owner (or manager) is easier to identify. He further mentioned that he encourages all condo associations and buildings owners to make face-coverings mandatory in common areas, but that it will not be provided in the City's by-law on COVID-19-related measures.

7) Perla Muyal

The resident first inquired about the exception provided in the City's COVID-19related by-law for customers with a justifiable medical condition, more specifically, if commercial establishments should be asking for supporting documentation; to which Mayor Brownstein responded that there is no provision on this question in the by-law, but that commercial establishments and the population should be reasonable in applying this exception.

The resident further inquired about the written attestation that commercial establishments must sign and send to the City as provided by the COVID-19-related by-law; to which Mayor Brownstein provided further explanations about the document, namely, that it is a way for the City to be made aware of commercial establishments' undertaking to respect the measures provided by the by-law.

WHEREAS under section 59 of the Act, every municipality must be represented on the urban agglomeration council;

WHEREAS according to section 61 of the Act, at a meeting of the council of a related municipality, the Mayor informs the council of the matters that are to be considered at a future meeting of the urban agglomeration council, sets out the
