## MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, AUGUST 10, 2020, AT 8:00PM BY WAY OF VIDEOCONFERENCE<sup>1</sup>

### **QUESTION PERIOD**

The question period started at 8:08 p.m. and finished at 8:36 p.m. Eight (8) people submitted questions prior to the holding of tonight's meeting and they were answered during the live feed.

Mayor Brownstein read out the first six (6) questions in consecutive order as they all dealt with the same topic, more specifically, the situation of religious institutions in the City of Côte Saint-Luc and the City's action plan to deal with several of these institutions located in residentially zoned areas. Mayor Brownstein subsequently answered all six (6) questions in one detailed answer which will be summarized hereunder. For the purposes of tonight's minutes, the names of each person that submitted a question related to this topic will be individually listed hereunder as well.

Mayor Brownstein responded to the numerous questions on the presence of non-conforming synagogues in residential zones by explaining that the City of Côte Saint-Luc is "a City of tolerance and (has) balanced the benefits that the multitude of non-conforming institutions have provided based on the service they give residents while understanding the inconvenience that other residents feel, and having forced parking, noise and garbage restrictions and more recently COVID-19 regulations." Mayor Brownstein further explained that "over more than 20 years, approximately 8 new congregations were formed in private homes, unlike the large buildings that house synagogues or churches and mosques, these smaller congregations were formed in regular single-family homes and duplexes". He further indicated "that City Councils of Côte Saint-Luc over the last 20 years have shown tolerance of small congregations serving the needs of the community" and that is why these institutions are still operating to this day.

Mayor Brownstein continued by mentioning a proposed solution for this issue, namely: "that the Current City Council has agreed that it is time to regularize the

situation. The City is drafting or looking into the way in which to do so. We want to allow small congregations, where the public agrees, to be rezoned as residential religious institutions or religious institutions constructions provided the owners of the properties upgrade them to comply with that use because once you're zoned as such, the requirements are more strict, and of course, subject to the proper legal process."

In the interim, Mayor Brownstein mentioned that Council "has agreed unanimously to not allow any new non-conforming religious institutions to pop up" and that the City "will be consulting the public on the existing ones, on potential commercial zones such as strip-malls, and we will find ways to accommodate everyone."

Councillor David Tordjman also provided comments on the topic of non-conforming religious institutions, more specifically that this matter does not concern the COVID-19 situation or the outdoor prayers that are being held in backyards. He further explained that "over the last 10 years, the demographic of Côte Saint-Luc has changed, and we continue to grow as a city. More and more young families are joining our community and helping it survive. With the influx of new families comes the need for better services, both private and public". Councillor Tordjman further mentioned that Council has a responsibility to Côte Saint-Luc residents to resolve issues such as this one. He further indicated that Council "made a commitment as a Council at the beginning of this mandate to resolve the issue of non-conforming houses of worship and to date, it is still not yet resolved. It's festering discord in our community and you can see it on social media. All these establishments would like to be properly recognized and we committed to them to figure this out."

He continued by mentioning that ignoring this is issue has caused a "very polarizing problem in the community" and that no "clarity will come to us" if there is continued discord. He concluded by addressing the other members of Council "to commit to the residents of Côte Saint-Luc that by the next public meeting we are going to find a structure to solve this issue and we can provide much needed closure for all of our residents."

The resident further inquired about the closure of the Mikvah; to which Mayor Brownstein clarified that the closure was done by the SPVM due to the non-compliance with COVID-19-related measures.

The resident also inquired about the presence of inspectors at the homes of Rabbi's in the City; to which Mayor Brownstein responded that the inspectors were deployed to Rabbis' residences by mistake.

### 4) Sarah Bensimon

The answer to the resident's question was provided hereinabove.

### 5) Bev Walker

The answer to the resident's first question was provided hereinabove.

The resident also inquired about the number of fines that were issued over the last two (2) years to property owner's conducting business that is not allowed as per the property's zoning, such as commercial establishments or religious institutions in residential zones; to which Mayor Brownstein responded that he doesn't have the exact number and that information would have to be verified with the administration.

### 6) Subbiah Srinivasan

The answer to the resident's question was provided hereinabove.

### 7) Heather Trestan

The resident inquired about the issue non-residents parking their vehicles overnight parking on Eldridge (between Kildare and Mackle) as vehicles are left there from Friday into the weekend; to which Mayor Brownstein responded that there is a general tolerance on the entire territory of the City on Friday nights and that residents can contact him directly for any specific issues.

### 8) Jordy Reichson

The resident inquired about the locations that have been designated or will be designated within the City for the COVID-19 testing sites and if the City has a say in this decision; to which Mayor Brownstein responded that the City received a request from the CIUSS to implement a testing site into a vaccination site (when it is developed), but that the site is in a commercial establishment.

7. CDS will make payments of the principal and the interest to Members through electronic funds transfers and, for this purpose, CDS will directly withdraw the required amounts from the following account:

WHEREAS according to section 61 of the Act, at a meeting of the council of a related municipality, the Mayor informs the council of the matters that are to be considered at a future meeting of the urban agglomeration council, sets out the position the Mayor intends to take on any matter referred to at the urban agglomeration council meeting, discusses that position with the other members present and proposes the adoption of a resolution establishing the council's stance;

WHEREAS agglomeration council meetings may be held in September 2020 for which members of the municipal council shall establish the stance that it wishes to take;

#### **SECOND QUESTION PERIOD**

The second question period started at 9:11 p.m. and finished at 9:18 p.m. Two (2) people submitted questions and they were answered during the live feed.

Prior to the holding of the second question period, Councillor Dida Berku provided additional comments concerning the situation of non-conforming religious institutions, more specifically, that the questions that were submitted at tonight's meeting were very pertinent and helpful for the establishment of an action plan to find the appropriate balance between the services provided by the religious institutions and the neighboring residents' concerns.

### 1) Jordy Reichson

The resident inquired about the proposed plan to regulate zoning issues in the City, more specifically, if this will apply to all non-conforming uses or only religious establishments; to which Mayor Brownstein responded that the City will gather all the necessary facts and locations to ensure the appropriate uses are regulated for all situations.

### 2) Alison Weinburger

The resident inquired about the timeline for the renovations of Kirwan Park and the repaving of the basketball court; to which Mayor Brownstein responded that the scheduling is being discussed taking into account budgetary implications. Councillor Mitch Kujavsky further indicated that the project is ongoing and that he is planning to schedule a townhall meeting and that a grant application was also requested for the project. He also provided comments on the details of the renovation work and potentially forming a committee to discuss the project.

Subsequent to the second question period, Councillor Sidney Benizri provided additional comments on the topic of non-conforming religious establishments and echoed Councillor Tordjman comments on providing the appropriate services for the ever-changing demographics of the City.
