### **MAYOR'S OPENING STATEMENT**

Prior to tonight's meeting, Mayor Brownstein provided an update on the City's situation concerning the COVID-19 pandemic. Mayor Brownstein and members of Council also acknowledged the passing of four Côte Saint-Luc residents and extended their condolences to their families, and additional comments were made to highlight the lives of these four residents. Mayor Brownstein asked that a moment of silence be observed for the people who are affected by the COVID-19 virus and those who have passed away due to circumstances related to the pandemic.

Mayor Brownstein also congratulated Prof. Elliot Lifson on being appointed to the Order of Canada and Councillor Cohen provided further comments on this recognition.

## **QUESTION PERIOD**

The question period started at 8:22 p.m. and finished at 8:35 p.m. Four (4) people submitted questions prior to the holding of tonight's meeting, and they were answered during the live feed.

### 1) Norman Sabin

The resident inquired about the traffic lights (left turn signal) at the Kildare and Kellert intersection; to which Mayor Brownstein responded that a detection system will be put in place at that intersection in 2021, and that the equipment and infrastructure will be updated as well.

## 2) Simon Arzouan

The resident inquired about the synchronization of the traffic lights between Cavendish and Mackle; more specifically, the proposed work and schedule to resolve this issue; to which Mayor Brownstein responded that the problem was due to be fixed by Hydro-Quebec this past summer, but due to delays it was only done this past week and there have since been multiple follow-ups to ensure that the synchronization follows the recommendations formulated by the City's consulting firm.

## 3) Lior Azerad

The resident inquired about the matter of lead pipes on the territory of the City; more specifically, when were members of Council made aware this issue and the precautionary measures to resolve this issue; to which Mayor Brownstein responded that the acceptable limits of lead in drinking water had only been reduced last year (from 10 to 5 parts per billion) and staff recommended to Council that the City should do additional testing. Prior to last year, staff always informed Council that the City has actively respected the governmental requirements in terms of lead norms and testing.

## 4) Marissa Sidel Dubrofsky

The resident inquired about the City's plan to resolve the issue of lead pipes and the presence of lead in drinking water, more specifically; the lack of home entries for lead testing in the past seven (7) months and if the City has recruited residents who would voluntarily allow access in their homes to conduct the lead testing; to which Mayor Brownstein responded that the City updated its Action Plan in 2019 and he explained said Action Plan in detail:

- The first element of the Action Plan was encouraging the purchase of water filters for approximately 3,000 single-family homes and duplexes built prior to 1976. The City created an incentive by which residents can obtain a \$50 rebate for the purchase of a water filters (for fridges and water pitchers) and in 2021, an additional rebate of \$200 will be available for under-sink water filters;
- The second element of the Action Plan was widespread water testing; the City budgeted enough funds to test approximately 3,200 homes in 2020, but it was determined that tests wouldn't be conducted due to the uncertainty of the measures related to the pandemic. Therefore, it was announced that half the testing would be done in 2021 and the other half in 2022. The minimum requirement for testing remains 40 homes per year, therefore, the City requested volunteers to participate and all 40 spaces were filled;
- The third element of the Action Plan is the replacement of the lead pipes; which is very costly and challenging since one section of the pipe belongs to the City and the other sections belongs to the homeowner, therefore the work must be coordinated between the two parties. Furthermore, the work must be coordinated with the replacement of sidewalks. The City is currently studying the matter and it will be done.

Mayor Brownstein further indicated that there is a lot more information on the City's Action Plan on the website.

Councillor Berku also indicated that at tonight's meeting Council will be awarding a contract for lead water sampling in 2021.

Councillor Erdelyi also indicated that the Quebec government modified its protocol for lead water sampling, namely, that the sampling takes longer and therefore, it wasn't advisable during the pandemic.

RESOLUTION IN SUPPORT OF THE RESOLUTION PRESENTED TO THE MONTREAL AGGLOMERATION CONCERNING THE STRATEGIC PLAN FOR THE DEVELOPMENT OF PUBLIC TRANSIT 2021-2030 - ARTM

WHEREAS, on October 27, 2020, the ARTM launched a major public consultation in order to finalize its first *Plan stratégique de développement du transport collectif 2021-2030* ("PSD") and to identify, among other things, priorities for structuring projects in key corridors;

WHEREAS the Namur-De la Savane ("NDLS") sector, which includes Décarie Square sector and Cavendish Boulevard in the City of Côte Saint-Luc ("CSL"), is one of the six priority sectors for development on the Island of Montréal. Located close to the main transport infrastructures, this predominantly industrial sector has excellent potential for urban requalification, with the Royalmount project to the north and the former Hippodrome and Décarie Square to the south, despite significant constraints;

WHEREAS in March 2019, in the wake of the consultation surrounding the Royalmount project, a working group chaired by Professor Junca-Adenot was created by Mayor Plante and Chantal Rouleau, Minister for Transport and Minister Responsible for the Metropolis and the Montreal Region, to propose solutions that would improve traffic conditions in the large NDLS sector and on its bordering highways, while relying on a vision of sustainable development for the sector;

WHEREAS the NDLS Working Group has concluded that the current situation clearly shows that there is a need, first of all, to open up the sector and significantly reinforce the public transit network in order to improve accessibility and reduce the overall volume of trips that clog the highway network and the Namur–De la Savane sector:

WHEREAS the City of Montréal and the ARTM participated directly in this NDLS Working Group as members of both the Management Committee and the Technical Committee, contributing to the 13 recommendations and 35 proposed actions in the report of the NDLS Working Group. The ARTM is also identified as the lead for the majority of the actions;

WHEREAS, despite these recommendations which were strongly supported by the Mayor of Montreal, the Minister, and the four mayors of the cities and boroughs concerned, namely the boroughs of CND-NDG and Saint-Laurent, and Town of Mount Royal and the City of Côte Saint-Luc, the ARTM has not to date acted on the majority of the recommendations to reduce congestion and advance the overall vision and planning of the sector;

WHEREAS the NDLS sector is not even mentioned in ARTM's PSD on the list of structuring projects under study or planned for implementation, except for the extension of the western branch of the orange line of the metro to the Bois Franc station of the REM:

WHEREAS the OCPM's report on the Quartier Namur-Hippodrome project, dated September 17, 2020 and submitted to the Council of the City of Montreal, reiterated and reinforced the recommendations of the NDLS Working Group that all transit and mobility measures be put into action before undertaking development of the area, and stressed the ARTM's important role in the implementation of key public transit projects;

WHEREAS, further to these consultations, studies and reports, the mayors of the cities and boroughs concerned by the Cavendish project and its connectivity with the NDLS requested from the City of Montreal that all required studies, including the electric public transit (tramway) scenario, be advanced as soon as possible, since the addition of the tramway should be included in the ARTM's PSD;

WHEREAS the City of Côte Saint-Luc is currently experiencing a major redevelopment boom on its territory, with potential mixed-use TOD projects on three dilapidated commercial sites at Décarie Square (in the northeast), Côte Saint-Luc Shopping Center (in the southwest), and Quartier Cavendish (in the centre). Each of the three promoters of these sites is committed to a sustainable development approach based on traffic-oriented development;

WHEREAS the success of the NDLS and City of CSL's requalification projects depends largely on the ability of the ARTM and public authorities to take structuring measures to improve neighbourhood connectivity, promote the use of public transit and limit the effects of the arrival of new households on heavily congested roads;

WHEREAS, in order to realize the full potential of the TOD "super urban" neighbourhood projects, it is essential to add a train station at the Côte Saint-Luc Shopping Center and at Square Décarie. The densification of the sectors and the development of active transit networks around and towards the stations will in turn allow the development of traffic on the EXO Saint-Jérôme line and optimize its use:

WHEREAS billions of dollars of private investment are expected in the NDLS sector and in CSL over the next 10 to 15 years, this is a historic moment for the metropolis to implement the transition from a large auto-centric urban sector to a mixed TOD sector;

WHEREAS the transport authorities suffer from underfunding, the redevelopment of the NDLS sector provides an important source of land revenue that can help finance future public transit projects;

WHEREAS the ARTM is the agency with the responsibility and obligation to address these deficiencies in transportation and mobility in this vital sector in the heart of the island, it is reasonable to expect that the Jean-Talon Namur-Hippodrome-De la Savane corridor linked to Cavendish extension will be included in the list of structuring projects of the PSD for the next 10 years;

WHEREAS the City of Côte Saint-Luc supports the resolution concerning the ARTM's Strategic Plan on the agenda of the Agglomeration Council of December 17, 2020;

To ask the ARTM to include the expanded NDLS sector on the list of structuring public transit projects in its 2021-2030 strategic plan in order to implement an interconnected public transit plan that meets the needs of the sector's current and future residents, employees and users;

To request the ARTM to add two train stations along the current EXO Saint-Jérôme line 1) between the Hippodrome future development and the Square Décarie and 2) at Côte Saint-Luc Shopping Center;

To ask the ARTM to proceed, starting in 2021 and as a priority, with the study of the electric public transit (tramway) structuring project on the axis of Jean-Talon Boulevard through the Namur-De la Savane sector and the extension of Cavendish Boulevard North towards the Côte-de-Liesse economic hub and along Cavendish Boulevard South towards the Turcot Lachine East economic hub;

To ask the ARTM to recognize the transportation needs of the aging population and to integrate them into the strategy;

To request the ARTM to Introduce and implement rules, guidelines and programs to encourage developers to provide and fund transportation solutions along major transit corridors such as Décarie."

- 1- In order to fit the new budget, some of the lower priority streets were removed from the list or moved to a later year.
- 2- The scarification of CSL road was removed in 2021 to allow a proper budget for the remaining streets.
- 3- Streets with lead replacement were put as a higher priority than streets without any lead issues.
