MAYOR'S OPENING STATEMENT

Prior to tonight's meeting, Mayor Brownstein provided an update on the City's situation concerning the COVID-19 pandemic and asked that a moment of silence be observed for the people who are affected by the COVID-19 virus and those who have passed away due to circumstances related to the pandemic.

QUESTION PERIOD

The question period started at 8:05 p.m. and finished at 8:17 p.m. four (4) people submitted questions prior to tonight's meeting, and they were answered during the live feed.

1) Raoul Fox and Ginette Ayache

The residents inquired about the status of the by-election for District 8 of the City; to which Mayor Brownstein responded that the by-election was postponed and that the seat will be filled at the 2021 municipal general election and he further added that residents of District 8 can reach out to him directly for any questions they may have.

2) Corinna Groenendaal

The resident inquired the sanitary measures related to the City's new toboggan run, more specifically, residents and employees wearing masks and maintaining a distance of 2 meters; to which Mayor Brownstein responded that Public Works will be monitoring the situation closely. He further clarified the rules pertaining the

wearing of masks outdoors, namely, that it is recommended to wear a mask when it is impossible to maintain a distance of 2 meters between people.

3) Norman Sabin

The resident inquired about the four-way red lights for the pedestrian walkway at the intersection of Heywood and Kellert and more specifically, that these lights are not necessary since residents often cross the street when they are not supposed to; to which Mayor Brownstein responded that this matter can be studied again by the Traffic Committee, but the reason it exists is to protect pedestrians that respect the street crossing rules at that specific intersection.

4) Marissa Sidel Dubrofsky

The resident inquired about the City's timeline to reopen certain services to the community (such as parks, pools and splash pads) given the decrease in positive COVID-19 infection rates and the upcoming spring and summer months; to which Mayor Brownstein responded that the City will reopen this summer like it did last year, but the City will monitor the public health guidelines in order to reopen its facilities in the safest way possible.

WHEREAS respect is a fundamental principle of democratic society, which in turn requires fundamental recognition of major freedoms, including freedom of expression;

WHEREAS a respectful democracy honours its elected offiicials and ensures the quality and authority of its institutions;

WHEREAS the *Union des municipalités du Québec* ("UMQ") has launched a province-wide campaign to promote democracy and respect;

WHEREAS on December 4, 2020 the members of the UMQ board of directors adopted the following declaration of commitment:

"Our democracy is rooted in our history. We ourselves choose the men and women who will govern us. In a democracy we can all be candidates for public office. When elections take place, citizens delegate the administration of their common welfare to people who offer their services, as we do. This way of managing our communities and regions has helped us attain one of the highest standards of living in the world – living in safety, living our lives as we wish, and freely expressing ourselves.

Debate and a spirited exchange of ideas are the lifeblood of democracy. This is possible as long as people respect one another. But these days, our democracy is too often abused in unfortunate ways: offensive behaviour, disrespect, threats, intimidation, and identity theft. In recent years, especially since the rise in popularity of social media, vigorous but respectful debate has too often been replaced with insults, threats, and intimidation.

This was already true before the pandemic. But the pandemic has only made things worse. That this crisis should be a cause for concern and anxiety is perfectly normal. That we may sometimes disagree with decisions made by the authorities is also normal. What is not normal or acceptable is that the women and men who exercise public responsibility by serving their fellow citizens should be intimidated, driven to resign, sometimes even facing death threats, or forced to move about with police protection.

In less than a year, local elections will be held in all Quebec municipalities. Between now and then, we must take better care of our democracy. We must return to debate that respects people and institutions so we can make the best possible decisions together. Let us remember that elected officials and public officers are committed to the well-being of the people they represent. Let us encourage political commitment, not discourage it.

As elected municipal officials, we are proud to serve our fellow citizens. That is why we are calling for a respectful democratic debate. Because "Democracy with Respect, out of Respect for Democracy." And we invite elected officials in all Quebec municipalities to join us in this movement;
