MAYOR'S OPENING STATEMENT

Prior to tonight's meeting, Mayor Brownstein asked that a moment of silence be observed for the people who are affected by the COVID-19 virus and those who have passed away due to circumstances related to the pandemic.

COVID-19 UPDATE

Mayor Brownstein provided an update on the City's situation concerning the COVID-19 pandemic and more specifically, regarding the number and nature of cases, vaccination clinics and encouraging residents to get vaccinated. Councillor Oren Sebag provided comments on front-line workers and encouraged residents to get vaccinated. Councillor Mike Cohen provided comments on vaccination passports.

DECARIE SQUARE UPDATE

Mayor Brownstein and Councillor Oren Sebag provided comments on the Decarie Square pilot project to reduce vehicle traffic in that area.

QUESTION PERIOD

The question period started at 8:14 p.m. and finished at 8:24 p.m. Five (5) people submitted questions prior to tonight's meeting, and they were answered during the live feed.

1) Mick Guttman

The resident inquired about the reopening of the showers at the public swimming pools (interior and exterior); to which Mayor Brownstein responded that due to the public health guidelines, the indoor showers will remain closed and that City administration is looking into the matter for outdoor showers.

2) Isak Moskatel

The resident inquired about the proposed construction project on the corner of Westminster Avenue and Mackle; to which Mayor Brownstein responded that the Planning Advisory Committee had refused the proposed project and no new proposal has since been submitted.

3) Alex Gorchkov

The resident inquired about the proposed zoning amendment for the property located at 5475 Westminster which will be presented at tonight's meeting; more specifically, concerning the sanitation issues as well as the proposed construction project; to which Mayor Brownstein responded that the City has met with the tenants of the building on numerous occasions as well as with the project developer, who has requested that the item on tonight's agenda be deferred.

Mayor Brownstein also referred the resident to the Urban Planning Department regarding his concerns on the building's sanitation issues.

4) Katia Gorshkova

WHEREAS to encourage municipalities to take concrete action to protect the monarch, the David Suzuki Foundation, in partnership with *Espace pour la vie*, has launched the Monarch-Friendly City initiative in Quebec, which aims to implement measures to restore the monarch's habitats and raise public awareness;

WHEREAS more than 340 mayors and municipal leaders in the United States have pledged to help save the monarch butterfly;

WHEREAS in Montreal, the initiative was launched in June 2017;

WHEREAS the cities of Montreal, Sainte-Anne-de-Bellevue and the borough of Saint-Laurent are already part of the program;

WHEREAS last fall the City of Côte-Saint-Luc ("City") became the 75th city in the province to be certified as a "Monarch-Friendly City";

WHEREAS the City has received a certification with a silver designation committing to implement at least 15 actions to save the monarch butterfly habitat;

WHEREAS the City's resident Ms. Myra Shuster, has agreed to spearhead the program and to raise awareness about the decline of the monarch butterfly and the species' need for habitat as a Monarch Ambassador to the David Suzuki Foundation:
