#### **MAYOR'S OPENING STATEMENT**

Prior to tonight's meeting, Mayor Brownstein asked that a moment of silence be observed for the people who are affected by the COVID-19 virus and those who have passed away due to circumstances related to the pandemic.

#### **COVID-19 UPDATE**

Mayor Brownstein provided an update on the City's situation concerning the COVID-19 pandemic and more specifically, encouraging residents to get vaccinated.

#### **SAUL SINGER TRIBUTE**

Council members paid tribute to Mr. Saul Singer who recently passed away. A video presentation was shown in his honour.

#### MESSAGE OF THANKS TO MEMBERS OF THE CITY STAFF

Council members provided comments and thanked all the members of the City's staff in view of their respective terms coming to an end shortly.

#### **QUESTION PERIOD**

The question period started at 8:34 p.m. and finished at 9:01 p.m. Six (6) people submitted questions prior to tonight's meeting, and they were answered during the live feed.

#### 1) Louise Legault

The intervenor highlighted that the 200 mètres Gardien de la rivière et de ses droits Group awarded a certificate of recognition to the City of Côte Saint-Luc for its work in saving the St-Pierre River on Meadowbrook; to which Councillor Dida Berku mentioned the raison d'être of the award and Councillor Steven Erdelyi also provided additional comments on the certificate while thanking the several intervenors.

#### 2) Norman Sabin

The resident inquired about the synchronization of the traffic lights on Fleet Road (East direction) in order to reduce the traffic flow on said street; to which Mayor Brownstein responded that the matter will be forwarded to the Engineering Department, but that the City is working on improving the traffic flow towards Decarie.

#### 3) Eveline Mascle

The resident wished to obtain information on the accomplishments of the Côte Saint-Luc City Council over the past four (4) years in reducing the effects of global warming; to which Mayor Brownstein, Councillors Steven Erdelyi and David Tordjman responded by detailing the several measures the City has established to improve the environment.

#### 4) Allan Benayoun

The resident inquired about potential development plans for Cavendish Mall site for additional housing; to which Mayor Brownstein responded that there are no existing plans approved by the City for that specific area.

#### 5) Phoebe Munro

The resident inquired about the proposed Minor Exemption for the property located at 5475 Westminster on tonight's Agenda and more specifically, she expressed concerns on the tenants' well-being throughout a construction project; to which Councillor Erdelyi responded to the resident's concerns including the protection of tenants' rights, the condition of the building and the potential increase in rent. Councillor Erdelyi and Mayor Brownstein further indicated that the proposed Minor Exemption on tonight's Agenda will be deferred to another meeting and that the concerns brought up by the resident can be addressed with members of Council and that an inspector will be sent to the property.

#### 6) Melodie Cohn

The resident inquired about Côte Saint-Luc's position on implementing a by-law for claw traps; to which Councillor Mike Cohen responded that the Public Security Department is looking into the matter and the way to implement the provincial regulation for these matters.

The resident also inquired about the reopening of COVID-19 testing centers in Côte Saint-Luc; to which Mayor Brownstein responded that the question will be brought up with the Santé Publique Montreal Office.

CDS will proceed with the transfer of funds, according to the legal requirements of the bonds and for that purpose; the Côte Saint-Luc City Council authorizes the City Treasurer to sign the documents required by the Canadian Banking system entitled: "Autorisation pour le plan de débits pré-autorisés destiné aux entreprises";
- 7. CDS will make payments of the principal and the interest to Members through electronic funds transfers and, for this purpose, CDS will directly withdraw the required amounts from the following account:
