THAT it be ordained and enacted by By-law 2537-3 entitled: "By-law 2537-3 amending By-law 2537 entitled "By-law to regulate the collection and disposal of residual materials" in order to amend the provisions regarding waste collection" as follows:

#### **ARTICLE 1**

Article 4 of By-law 2537 is hereby amended by repealing the definition of "Surplus bag".

#### **ARTICLE 2**

Article 9 of By-law 2537 is replaced by:

#### "9. Escape of residual materials into the environment

A receptacle or front-loading container must not be filled beyond the height of its walls.

Every person shall be responsible to contain all residual materials in their respective receptable or front load container so as to prevent the escape of the residual materials into the environment.

Each person is responsible for gathering residual materials that escaped from their receptable or front-loading container onto public or private property."

#### **ARTICLE 3**

Article 29 of By-law 2537 is hereby amended by repealing articles 29.1 and 29.2

# **ARTICLE 4**

Table 1 in Schedule B of By-law 2537 is hereby amended and replaced with the following table:
