MAYOR'S OPENING STATEMENT

Prior to tonight's meeting, Mayor Brownstein asked that a moment of silence be observed for the people who are affected by the COVID-19 virus or any other illness and those who have passed away due to circumstances related to the pandemic. Mayor Brownstein also encouraged residents to continue to wear masks indoors and to be vaccinated (against flu and Covid-19 variants) at the Decarie Square.

He further congratulated Parks and Recreation Department for the success of the swimming activity that took place last weekend and invited residents to attend the two budget meetings on Monday December 19th and Wednesday December 21st 2022.

QUESTION PERIOD

The question period started at 8:08 p.m. and finished at 8:23 p.m. Three (3) people submitted questions prior to tonight's meeting, and they were heard.

1) Wibke Scheid

The resident stated that the United Nations Biodiversity Conference: Cop-15 is currently taking place in Montreal and she urged Council members to take local action to preserve and restore biodiversity in the City of Côte Saint-Luc. The resident shared some proposals and questions regarding leaf blowers, length of lawns and Meadowbrook Road to which Mayor Brownstein responded that Council has taken some action regarding leaf blowers, for example by adopting By-law 2470-2 regarding nuisances. Councillor Erdelyi also added some comments regarding the by-law that prohibits leaf blowers during certain periods and can review a more significant ban in the next few years. He furthermore assured the resident that he will follow-up with the Public Works Department concerning the allowance to cut the grass at 15 centimeters. Concerning the road

Meadowbrook, he pointed out that there are some issues with bushes and trees that that threaten to fall on the road as well as issues with Hydro Quebec.

Finally, Councillor Berku mentioned that Côte Saint-Luc was the first city on the island of Montreal to adopt the resolution supporting the protection of the Techno Park and added that a communication was sent to Mayor Plante stating that the City of Côte Saint-Luc is in agreement with the 15 undertakings of the Engagement de Montréal that promote and encourage biodiversity and all the climates changes.

2) Norman Sabin

The resident inquired about the possibility of synchronizing the traffic light on Cavendish Boulevard between Merton and Fleet and proposed specific solutions as to the timing of each of the traffic lights between these intersections, to which Mayor Brownstein referred the matter and his suggestions to the traffic engineer (Mr. Yotis) who will directly follow-up with him. He also mentioned that the City has hired Consultants who are still working on efficient solutions, however, they have improved the flow and the safety at the intersections.

3) Brahm Shuster

The questioner inquired about the responsibility of the public safety officers in instituting and enforcing certain bylaws and more specifically regarding some renovations done by residents during the weekend to which Councillor Erdelyi responded that some bylaws fall under the responsibility of Public Security and some under the Urban Planning Departments. Mayor Brownstein also added that the main role of the public security officers is to ensure the safety of our city when they're driving the streets. Councillor Sebag further recommended people to call the dispatch Unit which is opened 24hours a day to report any issue they notice. Finally, Councillor Erdelyi, confirmed that renovation works are allowed during the weekend except some restricted hours.
