- 8) Furniture upgrades for the Library Café up to a maximum of \$10,000, plus applicable taxes, to be amortized over a period of five (5) years;
- 9) Purchase and installation of a dedicated HVAC unit for the ACC Server Room up to a maximum of \$17,400, plus applicable taxes, to be amortized over a period of five (5) years;
