WHEREAS a notice of motion for the present By-Law was given at the Special Sitting of Council held on December 19, 2022;

THAT it be ordained and enacted by By-Law 2470-3 entitled: "By-law 2470-3 amending By-law 2470 entitled: "By-law to regulate nuisance" in order to add infractions concerning public property", as follows:

#### **ARTICLE 1**

Article 4.1 of By-Law 2470 is hereby amended by replacing it with the following:

## "Article 4.1 - Public Property

- a) Damaging, defacing, or destroying urban furniture or the public domain.
- b) Affixing an object to or modifying urban furniture or the public domain.
- c) Climbing on urban furniture or the public domain or using it other than intended. The provisions related to climbing shall not apply to a playground structure designed for that specific purpose.
- d) Installing or relocating urban furniture other than by employees of the city or contractors hired by the City for this purpose.

#### **ARTICLE 2**

This By-law comes into force according to the law.
