#### **WELCOMING REMARKS BY THE MAYOR**

#### STEINER COFFEE PRESENTATION

A video presentation and commemorative plaque was given to Jack Steiner, age 10, who has a mobile barista business entitled "Steiner Coffee".

#### **QUESTION PERIOD**

The question period started at 8:00 p.m. and finished at 8:17 p.m. Two (2) people submitted questions prior to tonight's meeting, and they were heard.

#### 1) Lynda Fried

The resident complained regarding the state of the City's roads and also stated that the traffic lights on Fleet Road are not synchronized. Mayor Brownstein summartized the various road resurfacing projects for 2023 and how they will be logistically coordinated with the replacement of water service lines made of lead.

Mayor Brownstein then explained that due to a power outage, the lights on Fleet may have potentially lost their synchronization and, as such, the City is working with its salient partners to potentially remedy the situation.

#### 2) Norman Sabin

The resident called for a level crossing at Clanranald (north of Vezina) to alleviate traffic to which Mayor Brownstein explained that the City has already reached out to CP who have explained that level crossings across rail tracks can be dangerous. He then explained that the City is nonetheless very interested in finding safe ways to get pedestrians and cyclists across railway tracks via pedestrian bridges to connect different parts of Côte Saint-Luc currently divided by train tracks. He added that the City also wishes to increase connectivity by providing easier access to the Namur metro.
