WELCOMING REMARKS BY THE MAYOR

Prior to tonight's meeting, Mayor Brownstein, made an announcement on Something Rotten Musical performance by the Côte Saint-Luc dramatic society and Jane's Walk event; pictures of the event were presented.

PRESENTATION: SPOTLIGHT ON LOCAL MERCHANTS, BIJU STEPHANE ZNATY

Councillor Cohen introduced Mr. Biju Stephane Znaty and Mrs. Samara Namara and Mrs. Mary from Biju, a renown jeweller in Côte Saint-Luc.

A commemorative photo was then taken with Council and Mr. Biju Stephane Znaty.

DONATION TO THE CÔTE SAINT-LUC PUBLIC LIBRARY FOR A NEW SCIENCE FICTION AND FANTASY SECTION

Councillor Cohen introduced and thanked the Fagen family who donated to the City's library in memory of their father, Mr. Gary Fagen, for which a video was screened.

QUESTION PERIOD

The question period started at 8:20 p.m. and finished at 8:52 p.m. Eight (8) people asked to speak, and they were heard.

1) Norman Sabin

The resident inquired about traffic flow on Cavendish Boulevard between Merton and Fleet and suggested an 80 seconds cycle time instead of a 95 seconds to which Mayor Brownstein insured a follow up with the Engineering Department. Councillor Berku thanked Mr. Sabin for his time and his input on this matter.

2) Brahm Shuster

The resident inquired about who he should contact regarding his dissatisfaction of the customer service of an employee to which Mayor Brownstein and the City Manager responded that he should contact the Legal Services of the City.

3) Lynda Fried

The resident inquired about the conditions of the road and requested a list of road repair and the resident complained about traffic flow to which Councillor Erdelyi responded that the City is reconstructing about 1,800 square meters (1.5 kilometers) of sidewalk and 12,682 square meters (1.4 kilometers) of roads in 2023. He listed the streets that are to be repaved this year (2023), which are Fleet Road, Cavendish Boulevard., Sir Winston Churchill, Hartwell, Parkhaven and Merton.

4) Mark Needelman

The resident inquired on how water meters could be installed to determine the water consumption of each dwelling in a building where water is shared to which Mayor Brownstein responded that on the issue of water meters, the Quebec government requires all cities, to collect data on how much water is used in homes. The City's engineers will use this data to estimate the potable water consumption and how much water is lost. This spring and summer, water meters will be installed by some buildings and some houses and in the case of buildings, the owners will make some modifications to the plumbing and then eventually install the water meter wherever is the main water entry for the building. The building administration will then contact tenants to announce times when the water will be shut off and since there will be only one water meter in the building, there is no way to know how much water any individual apartment units consumes. Councillor Erdelyi added that the residents are charged on water bases on the value of their property.

The resident also inquired about the repaving of the roads in the City, to which Mayor Brownstein responded that this topic was answered in the previous question. He also added that the potholes in the City will all be filled.

5) Edna Janco

The resident inquired about the many requests for picnic tables for the Rembrandt Park to which Mayor Brownstein responded that last year twelve (12) benches were installed and that as for this year's budget, there isn't enough room for another one. He added that the council will take into consideration her request next year.

6) Jo Ann Goldwater

The resident inquired about the closing of the eastbound lane on Côte Saint-Luc Road between Smart and Westluke and requested that safety measures are taken to avoid confusion where drivers are driving in the wrong way, to which Councillor Erdelyi responded the City will look into getting this work resolve as quickly as possible.

7) Patrick Lortie

The resident inquired about the opening of Kirwan Park to which Councillor Kujavsky responded that the park could be opened in couple weeks (May 2023, weather dependant).

8) David

The resident inquired about the streetlight that never got back to normal since April 5th ice storm, to which Councillor Erdelyi responded that issue is related to

Hydro-Quebec and informed that the City has been contacting Hydro-Quebec to fix the light and that he will follow up with Public Works Department.

Annex A – REVISED MAY 2023

TERMS AND CONDITIONS OF THE PROGRAMME - REVISED

As of the coming into force of the present by-law, the City of Côte Saint-Luc ("City") will provide a rebate towards the purchase of water filters to every single-family home and duplex built prior to 1976, which are located in the areas in which the city believes there are water service lines made of lead. To apply for the rebate, applicants must complete the online application found on the City's website or fill out the form provided in Annex B of the present by-law. The rebate can only be applied to purchases from October 1, 2019, onward. The filter must be certified NSF/ANSI 53 or NSF/ANSI 58 for the removal of lead.

The rebates are as follows:

1) **An annual rebate up to \$50** for residents that purchase above the sink NSF-53 filter(s) to reduce lead in drinking water (see below);

Above the sink filter can be any of the following:

- **Pour-through pitcher/carafe**: Water drips through a filter in a water pitcher using gravity.
- <u>Faucet mount:</u> Mounts on kitchen faucet. Uses diverter to direct water through a filter.
- <u>Counter-top connected to sink faucet:</u> Connects to existing sink faucet through a hose/tubing.
- Refrigerator filter: Installed in your refrigerator and typically dispensed through the refrigerator door.
- Rental cost for a leased under-sink reverse Osmosis system installed in the Property owner's home.
- 2) A one-time rebate up to \$200 for residents that purchase an under-sink system certified NSF-053 or NSF-58 that connects to your plumbing under the sink.

In lieu of the rebates available in options (1) or (2) mentioned above, the City may provide, by request, a **one-time filtered water pitcher** (certified NSF-53) to qualifying property owners.
