ARTICLE 5-1. The terms of By-Law 921 concerning

Noise as amended by By-Law number 2138 are hereby declared to

extend and to apply throughout Zone 17 of the City.

ARTICLE 5-2. City of Montreal By-Law 4996 and any other dealing with the same subject matter are hereby repealed for Zone 17.

ARTICLE 6-1. The terms of By-Law 1039 concerning
Cleaning of Lots as amended by By-Law number 2138 are hereby
declared to extend and to apply throughout Zone 17 of the City.

ARTICLE 6-2. City of Montreal By-Law 5359 and any other dealing with the same subject matter are hereby repealed for Zone 17.
