WHEREAS a notice of motion for the present by-law was given at the Regular Sitting of Council held on June 13, 2022.

THAT it be ordained and enacted by By-law 2470-2 entitled: "By-law 2470-2 amending By-law 2470 entitled: "By-law to regulate nuisance" in order to amend the provisions concerning leaf-blowers" as follows:

**ARTICLE 1**

Article 9.4 of By-law 2470 is hereby amended, by replacing said article with the following :

**"Article 9.4 – Landscaping equipment**

Creating or tolerating any noise emanating from landscaping equipment, including a lawnmower or hedge-trimmer, between 11 PM and 7 AM."

**ARTICLE 2**

By-law 2470 is hereby amended by adding article 9.5 to Chapter 9 of said by-law which reads as follows:

**"Article 9.5 – Leaf-blowers**

Notwithstanding article 9.4, creating or tolerating any noise emanating from a leaf-blower, except:

- a) from September 1<sup>st</sup> to May 31<sup>st</sup>, between 8:00 a.m. and 5:00 p.m.;
- b) within the framework of municipal services."

**ARTICLE 3**

This By-law comes into force on April 28, 2023.
