WHEREAS by-law 2443 authorizing a loan of \$1,365,000 for renovating and upgrading the pump station located on Côte Saint-Luc Road, was adopted at a Regular Council Meeting held on February 9, 2015, was approved by the ministère des Affaires municipales et de l'Occupation du territoire on April 16, 2015 and came into force on April 28, 2015;

WHEREAS, by virtue of resolution number 160427, the City of Côte Saint-Luc ordered that the financing of expenses for the project be taken from the Water Financial Reserve;

WHEREAS, by virtue of resolution number 160718, the City of Côte Saint-Luc cancelled the loan by-law giving effect to its decision to pay for its portion of the project out of its water reserve account;

WHEREAS, consequently, the City of Côte Saint-Luc wishes to cancel the residual balance;

WHEREAS in order to cancel the residual balance, the Côte Saint-Luc City Council must repeal by-law 2443;

WHEREAS a Notice of Motion for this by-law was given at a Regular Meeting of Council on November 9, 2020 at 8:00 pm;

At its Meeting held on January 11, 2021 the Côte Saint-Luc City Council decrees that the following by-law be read as follows:

ARTICLE 1. The preamble of this by-law forms an integral part of thereof as if recited hereinafter at length.

ARTICLE 2. By-Law 2443 entitled: "By-law authorizing a loan of \$1,365,000 for renovating and upgrading the pump station located on Côte Saint-Luc Road" is hereby repealed.

ARTICLE 3. This by-law comes into force according to law.
