WHEREAS a notice of motion for the present by-law was given at the Regular Sitting of Council held on June 13, 2022.

THAT it be ordained and enacted by By-law 2537-1 entitled: "By-law 2537-1 amending By-law 2537 entitled "By-law to regulate the collection and disposal of residual materials" in order to amend the provisions regarding waste collection" as follows:

ARTICLE 1

Article 4 of By-law 2537 to regulate the collection and disposal of residual materials is hereby amended by:

 replacing the definition of the terms "blue bin", "brown bin" and "black bin" by the following:

"black bin": a black receptacle for the disposal of household waste, purchased from the City, with a capacity of 120 or 240 litres or a City-approved container with a capacity of 360 litres, regardless of color for the collection of garbage;

"blue bin": a blue receptacle for the disposal of recyclable materials, purchased from the City, with a capacity of 120, 240 or 360 litres;

"brown bin": a brown receptacle for the disposal of green waste and food waste, provided by the City, with a capacity of 120 or 240 litres; "

the addition, in alphabetical order, of the following definition:

"Surplus bag": Plastic bag identified by the City of Côte Saint-Luc, serving as an eligible plastic bag for the collection of household waste and used for the surplus of household waste at the volume allowed under article 29."

ARTICLE 2

Article 5 of this by-law is amended by replacing subparagraph (4)(b) by the following:

"b. a maximum limit of 360 litres per dwelling is set for sectors with household waste collection, excluding upholstered bulky items."

ARTICLE 3

Article 9 of this by-law is replaced by the following:

"9. Escape of residual materials into the environment

A receptacle or front-loading container must not be filled beyond the height of its walls.

Every person shall be responsible to contain all residual materials in their respective receptacle, front-load container or surplus bag so as to prevent the escape of the residual materials into the environment.

Each person is responsible for gathering residual materials that escaped from their receptacle, front-load container or surplus bag onto public or private property."

ARTICLE 4

This by-law is amended by the addition, after article 29, of the following articles:

"29.1 Additional black bin rental

Notwithstanding article 29, one (1) additional black bin with a 120 litres capacity serving a residential building, other than a townhouse, may be rented at the rates of \$100.00 from May 1st to April 30th or \$60.00 from May 1st to October 31st or \$60.00 from November 1st to April 30th and following conditions:

- A maximum number of two (2) bins, including the rented bin, is authorized per dwelling;
- 2) The maximum total capacity of bins, including the rented bin, is set at 360 litres per dwelling."

29.2 Purchase of surplus bags

The purchase of a maximum of twenty-five (25) surplus bags per dwelling is authorized per calendar year, at the rate of \$2.00 per bag.

ARTICLE 5

Schedule B of this by-law is amended by replacing Table 1 with the following:

Table 1: Quantity and size of receptacles and front-load containers for residential buildings, townhouses and exceptional buildings
