BY-LAW 2470-4 AMENDING BY-LAW 2470 ENTITLED: "BY-LAW TO REGULATE NUISANCE" IN ORDER TO ADD CERTAIN PROVISIONS

## **ALSO PRESENT:**

Florine Agbognihoue, Assistant City Clerk, acting as Secretary of the meeting.

WHEREAS a notice of motion for the present by-law was given at the Regular Sitting of Council held on March 11, 2024;

WHEREAS places of worship and education have increasingly been the target of manifestations in the Montreal area and elsewhere in Canada;

WHEREAS freedom of religion is protected by the Canadian Charter of Rights and Freedoms and by Québec's Charter of Human Rights and Freedoms;

WHEREAS the right to public instructions is guaranteed by Québec's Charter of Human Rights and Freedoms et the right to education and educational services by the Education act;

WHEREAS Council is of the opinion that citizens who exercise their freedom of religion have the right to do so in complete security and peace;

WHEREAS Council is of the opinion that the diversity of opinions and convictions warrants mutual tolerance of the respect of others;

WHEREAS Council is of the opinion that the imposition of a minimal distance from places of worship and from schools for manifestations is necessary and reasonable for ensuring public safety and maintaining public order, while respecting the rights and freedoms involved:

THAT IT BE ORDAINED AND ENACTED that By-law 2470-4 entitled: "By-law 2470-4 amending by-law 2470 entitled: "By-law to regulate nuisance" in order to add certain provisions", as follows:

### **ARTICLE 1**

By-law 2470 is hereby amended by adding article 4.5 in Chapter 4 of by-law 2470, which reads as follows:

#### "Article 4.5 - obstruction

Forbids for any person or group to demonstrate or protest in such a way that disturbs the peace, public order or public safety within a radius of 50 meters from the sidewalks of any building in IR - CC - CD and IN zone as defined in By-law No. 2217, Zoning Regulation of the City of Côte Saint-Luc."

# **ARTICLE 2**

By-law 2470 is hereby amended by adding a second paragraph to Article 11.3, which reads as follows:

It is forbidden for any person or group to demonstrate or protest in such a way that disturbs the peace, public order or public safety within a radius of 50 meters from the sidewalks of any building in an IR - CC - CD and IN zone as defined in By-law No. 2217, Zoning Regulation of the City of Côte Saint-Luc."

## **ARTICLE 3**

This By-law comes into force according to the law.
