QUESTION PERIOD

The question period started at 8:10 p.m. and finished at 8:38 p.m. Four (4) people asked to speak, and they were heard.

1) Sharon Friedman

The resident expressed her concern about the Cavendish Road extension and mentioned that she had called Minister Guilbeault in vain. She also inquired about the possibility of taking legal action because of the breach of agreement between

Minister Legault and Mayor Plante to which Councillor Berku responded that the ministers responsible for the Cavendish Road extension are the Minister of Finance (Mr. Éric Girard) and Mr. Pierre Fitzgibbon, the Minister responsible for the Montreal region. Councillor Berku also added that the mayors of Saint-Laurent, Côte Saint-Luc and Mont-Royal had contacted the ministers and that progress was being made. Finally, she pointed out that, since the blockage is at the level of the City of Montreal, only the provincial government can force it to respect the agreements and move forward with the Cavendish extension.

2) Noman Sabin

The resident expressed his concern about the closure of the King David residence and wondered if the Council could make a statement or do something about it; to which Councillor Erdelyi responded that he has been in contact with the owners of the King David residence and mentioned that, since the covid pandemic, they are having financial problems but that the City does not have the means to support them financially. He, nevertheless, pointed out that the residents are being helped to find new accommodation at a comparable cost and that they have already contacted the Waldorf residence, which has agreed to take in all the residents living there.

3) Hila Nobari

The resident stated that many owners of the building at 5700-5720 Cavendish are suffering tremendously from building management and board decisions that have defined the project without regard to residents' financial capabilities. She added that they have gone to great lengths to voice their concerns, gathering signatures from nearly 180 units who object to their financial and operational policies and who are experiencing problems related to the increase in assessments. However, their requests have been ignored and they have been forced to hire a lawyer to protect their rights, but they are also asking for the Council's help in this matter to which Mayor Brownstein expressed his sympathy for the problems she described. He then responded that Urban Planning staff have reviewed this file and spoken the building's co-owners and concluded that the City has no jurisdiction over these matters as a municipal government. This is a legal matter, and the co-owners should continue to consult their lawyer and contact the Régie du Bâtiment du Québec (RBQ), which has jurisdiction in this matter.

4) Kerri Lemberg

The resident inquired about the removal of Elise Gravels books from the shelves of the JPL and would like to know if the City plans to follow suit. He mentioned that Ms. Gravel has now dedicated her social media posts to blatant anti-Jew hatred and that her views and mission are incongruent to the City and the cultural policy to which Mayor Brownstein responded by reading the policy adopted by the City Council, which includes support for the position of the Canadian Federation of Library Associations. Mayor Brownstein also vigorously condemned the comments and positions of this author as unacceptable and totally contrary to the views of Council members and residents of Côte Saint-Luc. He finally concluded that the City will not appoint a committee to research all of the author's public statements, etc.

Councillor Sebag then shared his opinion on the topic and urged Council to take the necessary steps to remove these books from our library. Councillors Kujavsky and Cohen also expressed their opinion on the same topic.

MOTION URGING THAT A SECOND NATIONAL SUMMIT TO COMBAT ANTISEMITISM BE CONVENED

WHEREAS data from Statistics Canada and Jewish organizations such as the Centre for Israel and Jewish Affairs, Friends of Simon Wiesenthal Centre and B'nai Brith indicate a shocking rise in antisemitic incidents across Canada over the past years;

WHEREAS there has been a global surge in antisemitism since last October's terrorist attack by Hamas that led to the brutal murder of 1200 Israelis and to which Canada has not been immune;

WHEREAS since October 2023, Canada's Jewish community has witnessed shots fired at its schools, arson attempts at its communal buildings, boycott efforts and vandalism targeting private businesses simply because their owners are Jewish and the intimidation of its students at universities;

WHEREAS a first national summit to combat antisemitism was convened by then Special Envoy for Preserving Holocaust Remembrance and Combatting Antisemitism, the Honourable Irwin Cotler, in July 2021 in the wake of the war with Hamas in May of that year, alerting Canadians to a spiralling number of hate incidents including violent attacks on Jews in Toronto and Montreal;

WHEREAS that first summit led to Canada forming a high level delegation headed by Prime Minister Justin Trudeau that made robust promises to the International Holocaust Remembrance Alliance's (IHRA) Conference in October 2021 on how Canada could better confront hate aimed at Jews:

WHEREAS police departments across the country all report major and unprecedented increases in hate crimes since October 2023 with the Jewish community being by far the most targeted;

WHEREAS Marvin Rotrand, the outgoing National Director of B'nai Brith's League for Human Rights, has called on municipalities and school boards to adopt resolutions urging the convening of a second national summit;

WHEREAS the Government of Canada has appointed Deborah Lyons, Canada's former Ambassador to Israel, as the new Special Envoy for Preserving Holocaust Remembrance and Combatting Antisemitism;

WHEREAS the authority vested in her office permits her to be uniquely placed to convene and chair such a second summit;

WHEREAS a second national summit to combat antisemitism would provide a valuable forum for stakeholders representing all levels of government, civil servants, law enforcements, educators and community leaders to share information and agree on effective strategies to blunt the unprecedented wave of hate aimed at Jews;
