WHEREAS a draft by-law was adopted at a Regular Sitting of the City Council held on March 11, 2024;

IT IS ENACTED AND ORDAINED by By-law n° 2397-2 entitled: "By-Law to amend the potable water use By-law n° 2397 to adjust certain provisions."

By-Law n° 2397 entitled "Potable water use By-Law of the City of Côte Saint-Luc", as amended from time to time is hereby further amended as follows:

ARTICLE 1

Article 7.2.1 of the By-law is hereby replaced with the following text and table:

"7.2.1 Watering Periods

The watering of lawns, hedges, trees, or other vegetation is subject to the following conditions:

1° Where the civic address is an even number, watering is only permitted on the following days of the week:

Sunday	Monday	Tuesday	Wednesday	Thursday	Friday	Saturday

2° Where the civic address is an odd number, watering is only permitted on the following days of the week:

Sunday	Monday	Tuesday	Wednesday	Thursday	Friday	Saturday

- 3° Watering by automatic or programmable sprinkler systems is only permitted from 1:00 am to 6:00 am, and for a maximum duration of 15 minutes per zone.
- 4° Watering by all other methods, such as portable sprinklers, porous hoses, or manually activated sprinkler systems is only permitted from 6:00 pm to 11:30 pm, and for a maximum duration of 45 minutes.



ARTICLE 2

Article 7.2.2 of the By-law is hereby modified by the replacement, in the final sentence, of "April 1, 2024" with "June 1, 2025."

ARTICLE 3

Article 7.5 of the By-law is hereby modified by the replacement, in the final sentence, of "April 1, 2024" with "June 1, 2025."

ARTICLE 4

Article 7.6 of the By-law is hereby modified by the replacement, in the final sentence, of "April 1, 2024," with "June 1, 2025."

ARTICLE 5

The present By-Law shall come into force in accordance with the Law.
