WELCOMING REMARKS BY THE MAYOR

Prior to tonight's meeting, Mayor Brownstein welcomed the audience to the meeting.

A video was presented to promote justice, remembrance, cultural freedom and inclusion. This video was presented to thank the Kanien'kehá:ka Nation.

STATEMENT FROM THE MAYOR

Prior to question period, Mayor Brownstein mentioned that Bill 57 (Act to protect elected officers and to facilitate the unhindered exercise of their functions) concerning Incivilities has been tabled at the National Assembly of Quebec.

Mayor Brownstein highlighted Yom Hazikaron (May 13, 2024), Israel's official remembrance day dedicated to fallen soldiers and civilian victims of terrorism. He also mentioned Yom Ha'atzmaut (May 14, 2024), Israel's Independence Day and

talked about some of Israel's accomplishments in science; medicine before sharing some related backgrounds facts.

Mayor Brownstein brought attention to the show "Into the woods" and invited everyone to go and see it at the Côte Saint-Luc Dramatic Society Theatre.

QUESTION PERIOD

The question period started at 8:17 p.m. and finished at 8:48 p.m. Four (4) people asked to speak, and they were heard.

1) Myrtis Fossey

The questioner inquired about the follow-up to the resolution on tuition fees and whether it was possible to reach Pascale Déry, Minister of Higher Education in Quebec, or how we could help her reconsider and repair the damage done to universities; to which Mayor Brownstein, Councillors Erdelyi and Shuster responded that the City had passed two resolutions and circulated them to various municipalities as well as to the Minister who had indeed been contacted. The questioner also inquired about the City's position in the event of a successful referendum on sovereignty and on the possible question of some kind of separation of the City, to which Mayor Brownstein replied that a partition resolution was passed many years ago. He then pointed out that Municipalities are created according to the will of the province, but that there's nothing wrong with having this discussion. However, he added that the City certainly wants to remain a part of Canada.

2) Diane Leibling

The resident, as the chair of Côte Saint-Luc cats committee, inquired whether the committee has Council's support regarding the expenses of the said committee (they need more money) and if Council is willing to continue supporting the program, to which Councillor Cohen responded that unfortunately the City had to cut in the Budget. However, he pleaded for other donors to help the committee continue its remarkable work.

3) Sharon Friedman

The resident inquired about when the Council will start "playing hardball" with the Agglomeration regarding the Cavendish extension. She wondered, for example, where the money is going, to which Mayor Brownstein responded that the citizens need to step in and ask questions because they're the ones paying the taxes; and he also emphasized the remarkable work accomplished by Councillor Berku. Councillor Sebag then added that there are limits to how much pressure the Council can exert because we are bound by different laws, contracts, etc. but that going to court is not strategically the right solution at this stage. Meanwhile, Councillor Azerad suggested building on what Councillor Berku is doing in the dossier.

Finally, Councillor Berku shared her opinion and informed the audience of the launch of the "Plan Directeur d'Aménagement-Développement du quartier Namur hippodrome" which doesn't mention the Cavendish extension. She pointed out that on May 15, 2024, there will be a session open to all, at which the City of Montreal will present the said Plan. In addition, the 3 mayors are working on an upcoming information session open to the public.

4) Norman Sabin

The resident inquired about STM bus transportation in Côte Saint-Luc. He noticed the disappearance of shuttle no. 262 and wondered if the service would be restored;

to which Councillors Berku and Erdelyi responded that the STM had withdrawn this bus during the Covid due to a budget deficit and that it would not be reinstated. The resident also inquired about the routes of certain buses (104 and 138) in the city and made some recommendations. Mayor Brownstein invited the resident to send his suggestions to his office, which would forward them directly to the STM. In addition, Councillor Kujavsky did a quick search online and discovered that there is a question period on STM meetings and recommended that the resident attend.

RESOLUTION REGARDING THE CENTRE DE TRAITEMENT DES MATIÈRES ORGANIQUES IN SAINT-LAURENT

WHEREAS the City of Côte Saint-Luc ("City") was the first city on the Island of Montreal to implement curbside organic waste collection for all homes and duplexes in 2008;

WHEREAS the City, along with other cities on the Island of Montreal, are responsible for the collection and transport of residual waste;

WHEREAS the Agglomeration of Montreal is responsible for the treatment and disposal of residual waste on the Island of Montreal;

WHEREAS the Agglomeration of Montreal has asked Côte Saint-Luc and approximately 12 other demerged cities and Boroughs on the Island of Montreal to send their organic waste to the CTMO (Centre de Traitement des Matières Organiques) site located in Saint-Laurent;

WHEREAS in visiting the new CTMO site, a team from the Côte Saint-Luc Public Works department has identified multiple deficiencies in the site related to efficiency, safety and logistics of collection, including but not limited to the following:

- The facility's private road has only 2 lanes; one to enter and one to exit,
- Only one scale to weigh vehicles,
- Only two doors to enter the drop off site, which will not be sufficient during peak hours and seasons,
- Drivers must exit their vehicles to wash their tires before leaving the site, rather than installing an automatic system,
- Only one mechanism to treat the compost. If any of the machinery on the treatment line breaks, such as the grinder, the whole system comes to a halt,
- This site will not accept non soiled cardboard and certified compostable bags.

WHEREAS, since the City of Côte Saint-Luc began organic waste collection, councillors and staff made presentations on the program to the Commission des transports et de l'environnement de l'Assemblée nationale du Québec and to the Commission du conseil d'agglomération sur l'environnement, le transport et les infrastructures as part of the Plan directeur de gestion des matières résiduelles;

WHEREAS in 2022, only 35% of organic waste on the Island of Montreal was diverted from landfills;

WHEREAS the *Plan directeur de gestion des matières résiduelles* has set a target to divert 60% of organic waste on the Island of Montreal by 2025;

WHEREAS it is expedient for the Montreal Environmental Division to review the concerns of the Côte Saint-Luc Public Works Department and meet with them;

THAT Council requests that the Agglomeration of Montreal review its longterm plans to meet the target of 60% diversion including to allow certified compostable bags as is done in most in provinces across Canada and all cardboard to be included with the organic waste materials;

THAT Council requests that until these issues are resolved to our satisfaction, the organic waste collected by the City of Côte Saint-Luc continue to be sent to the current site at GFL Matrec Saint-Hubert;
